## Special Election and By-laws

Need to pass bylaws, then hold special elections. The old bylaws did not allow for multiple positions. New, clean version of the bylaws will be sent, as well as explanation for why there are going to be changes. Last year, the election was held on February 25 . We will hold the annual meeting virtually. We should find a full slate of candidates for the positions. We will aim to hold the annual meeting on January 28. Three people have expressed interest. There was discussion about how many vicepresidents should run. Unclear if people are allowed to run for multiple positions at once. At the election for the bylaws, we could also vote for a new President. We will distribute the notes from the bylaws discussion. We will hold an annual meeting to vote on bylaws. We will have a second meeting a week later that either elects a president (if the bylaws fail), or a slate of replacements (if the bylaws pass).
